I further agree to indemnify and hold the PHFOEC Providers harmless from any and all such suits, causes of action and claims by me or my child, or anyone else related to or associated with either of us, or anyone representing any of the foregoing. I understand and agree that, with respect to PHFOEC Providers, I am assuming all risk of illness, injury or other harm that I or my child may incur as a result of my or my child's use of the Bike and participation in the activity of mountain biking. I understand this agreement limits my legal rights and it is binding upon me, my heirs and legal representatives. If portions of this agreement are invalid, it is agreed the remaining portions will remain intact and enforceable. By signing the Release of Liability, I acknowledge I have fully read and understand the above and foregoing.
